Data Protection Statement

I declare that I accept and understand the following are my rights relating to my personal data and namely:

- i. The right of access - the right of information and that I can I access my personal data processed on me by the Association;
- ii. The right of rectification - the right to ask the Association to amend and update information which is incorrect or incomplete;
- iii. The right of cancellation - the right to request that the Association deletes my personal data;
- iv. Right to restrict - the right to request that the Association temporarily and permanently stops the processing of my personal data;
- v. The right of objection -
 - a. Right at any time, to object that the Association processes my personal data on grounds relating to particular circumstances;

- viii. The right to present a complaint with the Commissioner of Data Protection Level 2, Airways House, High Street, Sliema SLM 1549, Malta through [https site: //idpc.org.mt/](https://idpc.org.mt/).
